# NOTE: Photos and receipts will not be returned. The Department may require a field inspection or additional documents when necessary.

- 1. On a separate sheet of paper, describe how the vehicle was built and by whom. If your application is for a trailer, include a drawing of the frame with a materials list.
- Attach original receipts for the following major parts: frame, engine, transmission, axles, body tub, and welding receipts. If your application involves a trailer, receipts are needed for axles, steel, or other framing materials and welding. If you purchased a vehicle or trailer already constructed, a title, bill of sale, manufacture statement of origin, or construction receipts and ownership history will be required.
- 3. Attach photographs of the vehicle/trailer showing all four sides.
